



VENDORS / RESELLERS PROVIDING HYPERCONVERGED INFRASTRUCURE SOLUTIONS

The National Student Financial Aid Scheme (NSFAS) is a public entity accountable to the Department of Higher Education and Training (DHET). It provides financial assistance to eligible students at public universities and at Technical, Vocational, Education and Training ("TVET") colleges throughout South Africa.

The NSFAS hosted data centre infrastructure is nearing end of life and needs to be refreshed by middle of 2019.

NSFAS hereby extends an invitation to potential vendors/ resellers to provide solution proposals for hyperconverged infrastructure. There will be an opportunity to attend a briefing session (date/s will be communicated) whereby more in-depth and technical questions can be posed in order to obtain further inputs into the proposals.

Vendors may submit more than one proposal, either reflecting two different technologies or the same technology but with different configurations or options.

The NSFAS ICT are also able to facilitate the installation of sizing software if the vendor wishes to gather statistics on the workloads of the current environment. This is with regards to, but not limited to memory, compute, storage and network.

The current infrastructure includes:

- 1. 10 physical IBM servers (8 for inner server farm, 2 for DMZ)
- 2. 70 production virtual machines (95% Windows, 5% Linux), 85 non-production virtual machines
- EMC VNX 5300 SAN (60TB usable storage SSD, SAS & SATA), IBM Flashsystem 840
 (10TB usable storage)



- Brocade SAN switches, Cisco network switches, Fortigate firewalls, F5 Load Balancer,
 Barracuda Web Application Firewall (virtual)
- 5. Veeam backup software, EMC Data Domain backup devices
- 6. Disaster Recovery as a service

- Capacity planning / forecasting / predictive analysis (sizing tool & what-if scenarios)
- Cost analysis of migrating work loads to the public cloud
- Disaster Recovery capability (public cloud or other)
- Backup and archiving capability (public cloud and/or data domains)
- Local non-shared direct attached storage
- Storage capabilities (deduplication, compression, replication etc)
- Intelligent data tiering (across SSDs and HDDs)
