




No evidence found: Former NSFAS Board Chairperson Ernest Khosa cleared through independent investigations

NSFAS Administrator welcomes the report and the subsequent legal opinion from Tshisevhe Attorneys.

The former National Student Financial Aid Scheme (NSFAS) Board Chairperson, Mr Ernest Khosa, has been declared innocent on allegations of fraud and corruption levelled against him. This comes after a report by Advocate William Mokhare SC and a subsequent opinion from the Tshisevhe Attorneys incorporated (TGR) found no evidence to support these allegations.

In December 2023, the Organisation Undoing Tax Abuse (OUTA) accused Khosa of defrauding NSFAS through kickbacks from service providers. This came after audio recording of Khosa surfaced in the media with "Khosa attending a secret meeting with two NSFAS service provider individual to discuss confidential Board matters," OUTA claimed.

On Friday, 03 May 2024, in a statement published by NSFAS' Office of the Administrator, Mr Freeman Nomvalo welcomed the report on the matter announcing that NSFAS will in due course indicate plans to implement the recommendations of the report.

Forming part of the recommendations by Advocate Mokhare SC:

- The Board should be guided by legal opinions from experts in administrative law in order to minimise NSFAS exposure to potential damaging claims;
- The Board should reprimand Mr Khosa for his actions, which is for discussing the Board and Board decisions with Ntumba and Maluleke, and for failing to inform the Board about such discussions;
- The Board should expedite the implementation of the remaining

recommendations of the Werksmans report and take a decision on how it would implement the termination of the contracts of service providers without prejudice the beneficiaries of the student's allowances.

I have received complaints regarding alleged outstanding payments for private student accommodation.

I have also been made aware that in some areas, the landlords have allegedly locked-out students. Given the gravity of this situation, I have assigned NSFAS staff to urgently attend to these matters. I anticipate that these should be resolved during the course of the month of May 2024.

To ensure that these developments do not further disrupt teaching and learning, I would like to urge the affected landlords to cooperate with the established NSFAS process to attend to all concerns.

A dedicated email address has been established to process all disputes or concerns. All landlords are encouraged to deposit their disputes or concerns only in so far as outstanding payments are concerned. Submissions must be received not later than the 10th of May 2024.

I wish to apologise to all affected Institutions, students and landlords and commit to a speedy resolution.

We are committed to working with all the stakeholders to find workable solutions for the betterment of the Post School Education and Training System.

N.B All disputes and concerns regarding alleged outstanding payments for private student accommodation must be deposited on this email address not later than the 10th of May 2024.

The management of performance is an accepted practice in the public sector. It aids departments and public entities in aligning employee efforts, resources and systems toward the achievement of strategic goals. The NSFAS utilises the Annual Performance Planning (APP) process to determine the strategic priorities, establish strategic goals and outcomes, and plan the delivery of performance for a financial year.

Line managers and employees then collaboratively plan how they can contribute to the achievement of APP goals and objectives through the Individual Performance Management Process.

Individual Performance Management enables a line manager and employee to discuss and clarify performance goals and expectations for the year ahead. This performance planning discussion culminates in the completion of an Individual Performance Contract (IPC). IPC completion

is an important process as it provides the line manager with an opportunity to express performance expectations. Equally, employees participate in this discussion and are able to indicate where they can contribute and what assistance might be required in the pursuit of organisational goal achievement. The dialogue between line manager and employee also supports collaborative work and embeds the philosophy of team-based work execution.

The Performance Management process enables employees to improve productivity, obtain positive feedback, guidance and direction from management, and channels individual outputs towards improvement in the overall performance of the entity.

A well-functioning performance management system enables the entity

to recognise high performers and assist those that require support. The performance contracting window has been opened on the 16 April 2024 and is set to close on the 17 May 2024. All employees are urged to complete an IPC collaboratively with their line manager so that completed IPCs can be submitted to the Human Resources department by the due date.

#SA Elections 2024

Can I vote with my temporary registration certificate (TRC)?

No, you can only vote with your South African, green, bar-coded ID, smartcard ID or a valid Temporary Identity Certificate (TIC). You can apply for a green, bar-coded ID, smartcard ID or a valid Temporary Identity Certificate (TIC) from the **Department of Home Affairs.**

Can I vote on behalf of someone who is unable to get to their voting station?

No, every voter must vote in person at the voting station.

Can I vote if my new ID book has not arrived yet?

Yes, you can vote if you have a Temporary Identity Certificate (TIC) that is valid on Election Day. You can apply for a TIC at the **Department of Home Affairs.** Please remember, you will only be able to vote if you are a registered voter.

How does the IEC ensure security and non-intimidation at voting stations?

There are police and/or army personnel at every voting station to ensure your safety.

I am blind. Can someone help me at the voting station?

You can take anyone who is at least 18 years old and not a party agent with you to the voting station to help you cast your vote. You can also ask the presiding officer at the voting station to help you and/or provide you with a voting aid known as a universal ballot template (UBT).

I have registered, but I don't want to vote. Will anything happen to me if I don't vote?

No, voting is not compulsory in SA, however voting is an important civic duty and we encourage all South Africans to

Minister Nzimande launches R146million skills development centre in Groblersdal

On Friday, 03 May 2024, the Minister of Higher Education, Science and Innovation, Prof Blade Nzimande officially launched yet another state-of-the-art skills development centre in Groblersdal, Limpopo. The Sekhukhune Skills Development Centre in Acquaville is the Wholesale and Retail SETA's First Skills Development Centre.

Forming part of the amazing features of the skills centre is bulk earthworks, administration buildings, retail & agricultural hub for training, warehousing, four (4) engineering workshops; farming facilities, agroprocessing, retailing; and trading stalls for informal traders amongst others.

Addressing the launch attended by government officials, Sector Education and Training Authority (SETAs), business, traditional leaders and the community, Minister Nzimande called for collaboration to ensure that the youth is given the opportunities to change their lives.

"This centre is set to bring not only acquisition of new skills for the youth and learners around this area but will also yield more business opportunities and economic development," the minister said.

The minister added that, currently, the department is producing just about 20,000 artisans per year. "We are well on our way to reaching the target set by the NDP and our confidence derives from the potential that facilities such as the Sekhukhune Skills Development offer us," the minister said.
