### Taking Challenges of Students Head-on Through Stakeholder Engagements

On 16 and 17 May, 2024, The National Student Financial Aid Scheme (NSFAS) Administrator Mr Freeman Nomvalo, met with various key role players to discuss issues around the NSFAS accommodation pilot project and transportation of students residing private accommodations.

In his first meeting with accommodation providers, the engagement was necessitated by numerous complaints from landlords ranging from the non-payment of private accommodation providers, transportation challenges, regulations of the Capping System and disparities of allowances, the Grading System of accommodation providers, decentralisation of the NSFAS offices, and verification of students.

Amongst stakeholders present were the South African Union of Students (SAUS), South African Technical Vocational Education and Training Student Association (SATVETSA), Universities South Africa (USAF), the Department of Higher Education and Training (DHET), and private accommodation providers (APs).

The Administrator appealed for the establishment of a Task Team which will look into speedily resolving accommodation challenges, and highted that payments to accommodation providers will be processed from 25 – 31 May 2024, and again from 01 – 15 June 2024.

The Administrator also called for the institutions and landlords to work together, to ensure that everyone is

pulling their weight to better the system, for the benefit of

His second engagement with the Eastern Cape taxi industry was aimed at addressing the confusion around the role of NSFAS, institutions and private accommodation providers in the transportation of students.

The Administrator has also met with the MEC for Transport in the Eastern Cape, Mr Xolile Nqatha, to outline the concerns the taxi industry raised; which has since led to the proposition of policy change in relation to transportation of off-campus funded students.

# OUTA praises NSFAS Administrator for striking the right chords, and wishes him well

The Organisation Undoing Tax Abuse (OUTA) has praised and extended well wishes to the National Student Financial Aid Scheme (NSFAS) Administrator, Mr Freeman Nomvalo, after having identified several interventions to address challenges faced by the scheme

During a recent interview with the SABC, OUTA's Investigations Manager Mr Rudi Heyneke said OUTA is optimistic that NSFAS is heading towards the right direction.

This comes after the organisation noted efforts the scheme is making towards addressing its inefficiencies; particularly on non-payment of allowances, accommodation issues and poor systems.

"The intervention that took place in

2018 to provide free education was huge, and NSFAS is too important to fail. I do believe and hope that Mr Nomvalo will be able to change the face and the working of NSFAS, and I therefore wish him well," Mr Heyneke said.

In December 2023 OUTA raised a flag of corruption and fraud against the former NSFAS Board Chairperson Mr Ernest Khosa, accusing him of receiving kickbacks from service providers. Mr Khosa has since been declared innocent on these allegations following an investigation report.

The report has however advised NSFAS to expedite the implementation of the remaining recommendations of the Werksmans report and take a decision on how it would implement the termination of the contracts of service providers without prejudice to the beneficiaries of the student's allowances.

Speaking on how NSFAS is aiming to resolve issues around the delay and nonpayment of allowances to students, the Administrator said NSFAS is moving towards paying students directly in their bank accounts. "You only need an intermediary when that intermediary adds value in the process. The attitude that is prevailing is that we need to urgently introduce direct payments, for the benefit of the students," Mr Nomvalo said.

He added that anybody who militates against paying directly to students, would be militating against NSFAS in ensuring that it serves the society better.

### Progress in the payment of Landlords

The National Student Financial Aid Scheme (NSFAS) Administrator, Mr Freeman Nomvalo, has been consulting with the various stakeholders since his appointment as the Administrator. One of the critical stakeholders consulted are the landlords for private student accommodation, who amongst others, raised concerns regarding the outstanding payments of student accommodation allowances.

In response to these concerns, NSFAS is pleased to announce that, a bulk payment of accommodation allowances was processed by the end of May 2024 and beginning of June 2024. The next scheduled payment will be not later than the 18th of June 2024 to clear all legitimate claims. These interventions are intended to provide the much-needed relief to private student accommodation landlords.

The NSFAS Administrator pleads with landlords who still have outstanding payments not to evict students as NSFAS is committed to ensuring that all legitimate claims are resolved not later than the 18 June 2024. Landlords who did not submit their claims for outstanding payments still encouraged to refer their queries to our dedicated email address NSFASAccomProv@nsfas.org.za.

Furthermore, the Administrator reiterates his call to all TVET students who still do not have bank accounts to open the bank accounts with banks of their own choice and submit their bank accounts on the NSFAS established portal to avoid delays in the payment of their allowances. The banking details provided must belong to the student to enable NSFAS to verify these against the student's details on our record and minimize potential risks.

The Administrator has also become aware of what appears to be deliberate misinformation about the work of NSFAS in various social media platforms and wishes to encourage members of the public to only rely on official communication from NSFAS.

The Administrator reiterates his commitment to constructively engage with all stakeholders to find workable solutions for the stability of the PSET system and success of our students.

# Residents of the JTG District hails for more TVET colleges and universities

Over 15 000 residents from the John Taolo Gaetsewe (JTG) District, Kuruman, in the Northern Cape attended the last District Development Model Presidential Imbizo held on Thursday, 09 May 2024. Leading to the discussions to welcome President Cyril Ramaphosa, the Premier of Northern Cape Dr Zamani Saul, said the people came to attend the gathering with an overflow and massive expectations that the President will listen to their unheard cries.

Amongst some of the outstanding issues raised by residents was the lack of support and opportunities for young people with skills development and education, and those in need of assistance to establish businesses.

# Freeman Nomvalo frees NSFAS beneficiaries

The National Student Financial Aid Scheme (NSFAS) has devised a payment mechanism to address the ongoing allowance payment challenges with the assistance of its banker. This new approach aims to streamline the process and ensure that students receive their allowances in a more timely and efficient manner. By collaborating with their banker, NSFAS has implemented several measures to prevent delays and errors in the payment process. This includes improving communication channels, optimising the use of technology, and conducting regular assessments to identify any potential issues such fraud.

This endeavor stems from the difficulties they had with the four service providers assigned to pay allowances to NSFAS beneficiaries. The previous service providers encountered various challenges, including delayed payments or non-payments, the disappearance of allowances in student's accounts.

The student leadership highlighted that these challenges created distress and financial hardship for students who rely on these allowances to further their

education. As a result, the necessity for a fresh method to allowance distribution became clear.

This is another milestone achieved by NSFAS: to ensure that students' transition into post school education and training is smooth and uncomplicated, with no hassles about financial support. The organisation has made major efforts to simplify the process of obtaining financial help for students, recognising the importance of reducing barriers to

education. NSFAS aspires to empower students to achieve their academic ambitions without the burden of financial hardship by providing easy and quick ways to apply for and receive financial aid. # NSFAS prepares for the 2025 student funding journey programme

The preparation started in April, and inputs from internal staff has been collated in the form of lessons learned, regarding the challenges that we face in supporting the various processes linked to the onboarding, funding, payment and communications with students and stakeholders.

Some of the concerns are recurring and have been raised as issues in previous years, which means that we continue to repeat the same practices expecting different results.

Various engagements have been planned to address different aspects of the programme, which is intended to herald the commencement of a new way of working. Executives, Managers, and specialists who are critical to the process attended a two (2) day workshop on the 7th and 8th of May, 2024.

WORKSHOP OBJECTIVES: To unpack the NSFAS Value Chain by determining activities, scoping the roadmap, appointing process owners, setting timelines and assessing requirements and resources.

The two (2) day workshop highlighted Governance challenges related to frequent funding policy amendments and processing inefficiencies regarding confusing applications statuses, a difficult Appeals process, budget limitations, debilitating resourcing constraints and general stakeholder communication challenges.

The South African Technical and Vocational Education and Training Student Association (SATVETSA) and the South African Union of Students (SAUS) were allowed an opportunity to present their impact statements, both brought perspective on the gaps within the applications and funding confirmation processes. Both organisations have provided useful information and recommendations that will be incorporated into our remedial tasks as we built the roadmap to the 2025 student funding journey.

The reliance and use of third-party datasets i.e. SARS, SASSA, DBE and Credit Bureaus require refinement. Progress was made in the Prepare for cycle, Manage Applications and Determine Eligibility streams. The Confirm Funding, Pay student and Recover streams require more refinement. The discussions will continue, pay the student is core to the NSFAS mandate, a follow-up workshop was held on 13 May 2024 to wrap-up on the pending matters.

**Next action:** The project is now formarlly handed over to various teams within the organisation for implementation.
