Minister Nobuhle Nkabane delivers Higher Education and Training BUDGET VOTE 2024

"We have listened attentively to the voices agitating for transformation"

Two days prior to the annual International Commemoration of Nelson Mandela on 18 July, 2024, the Minister of Higher Education and Training Dr Nobuhle Nkabane, delivered the department's Budget Vote.

Dr Nkabane unbolted her Budget Vote speech with a quote from former President Nelson Mandela; which puts into to perspective the importance of education.

"Education is the most powerful weapon we can use to change the world." indeed, it is through education that the daughter of a peasant can become a doctor; that the son of the mineworker can become the head of the mine; that a child of a farm worker can become the President of a great nation", she recited.

With a budget of R137.5 billion for the 2024/25 financial year, and an annual average increase of 4.8% from R130.5

billion in 2023/24 to R150.2 billion in 2026/27, the minister says her department has attentively to the voices agitating for transformation

Dr Nkabane said some of those voices are those that lamented for the redress of inefficiencies emanating from the National Student Financial Aid Scheme.

"We have also listened to the silent prayers of parents; for the Department of Higher Education and Training to resolve current student funding and payment challenges. We have also listened to the voices of landlords providing accommodation to students, and to those providing transportation to student," the minister said.

With NSFAS having grown from disbursing R21.4 million in 1991 to almost R54 billon in the current financial year supporting 800, 000 students, the minister seeks to ensure that the department's goal of goal to expand access to higher education and training opportunities, and improve the quality of the provisioning, responsiveness

and efficiency of the post-school education and training system, is met.

"It is our commitment to root out corruption and maladministration in the NSFAS grant payment system. In this regard, we have committed funds to improve NSFAS Information Communication Technologies — inclusive of the loan system management. We acknowledge that some of the challenges have led to delays in the finalization and tabling in parliament of NSFAS annual reports," the minister said.

Dr Nkabane indicated that earlier this year, the department came up with a Comprehensive Student Funding Model whereby it committed R3.8billion initial capitalisation fund to support "missing middle" students; effective this financial year.

The "missing middle" is a category of students who come from families with total income of more than R350, 000, but not more than R600, 000 per annum.

Since its inception, NSFAS has supported more than five million beneficiaries, producing hundreds of thousands of skilled professionals and the middle class, especially from within the poor and working-class sections of society.

The minister said this is definitely one of the most important achievements of this government over the past 30 years of our democracy.

"We are working overtime to ensure that NSFAS systems are ready for the commencement of the 2025 application season — which is scheduled to start in September this year. This is critically important because in this financial year, NSFAS received approximately, two million applications for a bursary. Out of this volume, 419, 447 were returning students — while 297, 809 were First Time Entry students. Given these volumes, we are doing everything possible to ensure NSFAS systems are ready," she added.

TVETs Semester 2 applications are now open

The opening and closing dates for 2024 National Student Financial Aid scheme (NSFAS) Technical and Vocational Education and Training (TVET) Walk-In applications are aligned as closely as possible to the TVET academic calendar as issued by the Department of Higher Education and Training. Colleges that are participating in the Centres of Specialisation programmes, should encourage participating students to also apply during the available application window.

New applicants should also be reminded to not only create a profile and consider themselves to have

applied but should continue with the process of completing the application until the last step of submitting their application.

The 2024 second semester TVET application window opened on 09 July 2024 and will close on 26 July 2024.



Trimester 3 will also open on 02 September 2024, and close on 20 September 2024.

It is important to note that a student should apply for the relevant academic cycle which they intend to register in.

The method of application for all 2024 remaining cycles remains the same as the one which was utilised by students to apply for NSFAS funding for the 1st cycle of 2024, meaning the students will apply for themselves online through the NSFAS website.

NSFAS Student Accommodation Task Team unpacks challenges, and identifies resolutions



FINDING SOLUTIONS: NSFAS Student Accommodation Task Team locked in discussions to find solutions to student accommodation challenges.

The National Student Financial Aid Scheme (NSFAS) Student Accommodation Task Team gathered at the Birchwood Hotel in Johannesburg for a two days session, to find solutions to student accommodation challenges.

The meeting held from 26 - 27 June 2024, was attended by various key role players in post-school education and training, including private accommodation providers, the Department of Higher Education and Training (DHET), financial aid practitioners associations, student' union associations representatives - the South African Public Colleges Organisation (SACPO), South African Union of Students (SAUS), the South African Technical Vocational Education and Training Student Association, as well as the South African Association of Senior Student Affairs Professionals (SAASSAP) .

Appealing to the Task Team not to hold

back anything and bring forward all challenges faced, NSFAS Administrator, Mr Freeman Nomvalo, said NSFAS has already roped two auditing firms two assist in looking into challenges of accreditation, onboarding and payments.

"Our intention is that by the 31 December 2024, all accredited facilities are already notified, so that we start the new academic year with less challenge," Mr Nomvalo said.

Mr Khanyiso Sonti from DHET said it was prudent for the task team to review sections of the NSFAS policy on student accommodation to clearly outline the whole process flow, clarify grey areas, and delineate the roles and responsibilities of all the stakeholders.

SAASSAP which was represented by Prof Sibusiso Chalufu, said that unless all stakeholders move away from silos, there will always be challenges.

Prof Chalufu delineated NSFAS' decision

to take over the accreditation of private student accommodation facilities as breeding "deleterious consequences" for the higher education sector.

During a panel discussion, SAUS President Mr Yandisa Ndzoyiya strongly recommended that NSFAS should speedily look into developing an integrated system with accommodation providers that will assist in allocation of beds for students. Ndzoyiya further added that regular monitoring and evaluation of these accommodation facilities, will assist in ascertaining that students receive value for monies paid towards their accommodation.

According to the Financial Aid Practitioners of South Africa (FAPSA), the biggest challenge between stakeholders, NSFAS, Accommodation Providers and students is communication.

"We are however appreciative of the posture that NSFAS is taking of including everyone in the process. Good things are

coming" - President of FAPSA, Mr Jay Mahara said.

To ensure that all key challenges are looked into, four workstreams were commissioned namely: Accommodation Capping, Accreditation and Grading, Student Accommodation challenges for rural and semi-rural institutions, and Regulations for Private Student Accommodation.

During Day 2 of engagements, all commissions presented solutions and recommendations to be presented to the Administrator.

Advisor to the Administrator, Mr Mpho Diago said that the work of the Task Team will be delivered in the upcoming conference which is anticipated to take place in October.

However, of matters which would need immediate attention, recommendations would be presented to the Administrator.

This meeting with funders was aimed at reaffirming the scheme's commitment to maintain its collaboration and proactive measures taken to enhance its operational efficiency and governance.

The meeting provided a platform for funders to raise their concerns and find solutions to challenges.

Amongst other funders who attended the meeting was the Department of Employment Labour, the National Skills Fund (NSF) the Department of Social Development, FoodBev SETA, and the South African Council for Educators (SACE).

Mr Nomvalo said, recently, NSFAS had to deal with solving a great deal of problems, of which some were unfortunately generated by misleading reports in the media. He however, acknowledged that NSFAS is still trying to find its feet, with systems, delayed payments, and student accommodation being some of the challenges faced.

Update on the distribution of 2024 university allowances

Following a meeting Universities South Africa (USAf) and the Administrator of the National Student Financial Aid Scheme, Mr Freeman Nomvalo, NSFAS has decided that for the remainder of the 2024 academic year, university students' allowances will be distributed through institutions (universities).

This means that NSFAS will continue with the current arrangement, in which allowances are disbursed to institutions and subsequently distributed to

students until the conclusion of the 2024 academic year. This adjustment has no influence on the pilot accommodation procedure.

NSFAS will continue to disburse allowances and tuition fees to institutions based on the valid registration data received and processed successfully. NSFAS urged institutions to validate students' data before disbursing allowances to ensure that only qualifying students receive the correct amounts.

The scheme will communicate further with universities pertaining the 2025 academic year allowance distribution channels.

The scheme then requested that Institutions submit cancellations for the 2024 academic year by July 26, 2024. NSFAS will process and update registration records for the 2024 academic year as they are received.
