

# **READY TO SAIL:** NSFAS management and staff formally welcomes new Captain on board

## "There is no organisation that is dysfunctional" -

On Monday, 15 April 2024, the National Student Financial Aid Scheme (NSFAS) Executive Management and staff, welcomed the newly appointed Administrator, Mr Sithembiso Freeman Nomvalo.

Mr Nomvalo who has served in various leadership positions, was tasked with the momentous tasks of stabilising NSFAS, after the funding scheme was recently placed under Administration by Professor Blade Nzimande, Minister of Higher Education, Science and Innovation.

The new "NSFAS Captain" who has now taken over the governance, management and administration of NSFAS; was formally handed over to the management and staff by the Department of Higher Education and Training (DHET) Director—General Dr Nkosinathi Sishi and the Special Advisor to the Minister, Mr Nqaba Nqandela.

In his welcoming address, Mr Nqandela highlighted to the Administrator that one of the issues he needs to seriously deal with internally, is "Change Fatigue".

"Those who have served and led NSFAS before, we recognise them. However, people are tired. There has been so many new people that came and left. People are change fatigued. But because of the important role that NSFAS plays in the country, by virtue of you working here, it means that you are part of the disciples who believe in what NSFAS stands for," Mr Nqandela

Mr Nqaba added that, there is no one who can solely turnaround NSFAS, hence the appeal to all staff to work with the Administrator; and the department will also play its part

Dr Sishi spoke about the importance of communication and communicating on time to students; which translates to service delivery. "Service delivery is not always when you communicate that 'you have been funded', sometimes it is just to be told on time that unfortunately 'you will not be funded this time'. Just that response to a student is important enough," Dr Sishi said

Mr Nomvalo thanked everyone for the warm welcome, as he took to the podium to address all staff members.



The Administrator expressed the importance of acknowledging each other and the students NSFAS serve, as human beings.

This followed as the Administrator noted a report by the minister of a student who was not properly assisted

by staff members; labelling it as [not helpful and regrettable.]

"Failing to assist students and the lack of responding timeously, as the Dr Sishi said; dehumanises them," the Administrator said. Mr Nomvalo encouraged staff to always speak up, whenever challenges occur. "We need to create an environment that is safe for anyone to speak, and not wait until it is too late. Snitch, if you have to." he added.













Mr Nomvalo has over 25 years working experience, 17 of which were at senior level both in the public and private sector.

Mr. Nomvalo also holds the distinction of being the first African and longest serving Accountant-General of a democratic South Africa. He also possesses extensive knowledge and an impeccable track record in public finance and government processes.

In 2002 Mr. Nomvalo worked with the Reserve Bank to resolve the Banking crisis as well as clear the accumulated losses on the Gold and Foreign Exchange Contingency Reserve Account. He was asked to serve on the Cricket Committee established to help resolve Cricket South Africa challenges in 2012. He recently served on the Ntsebeza Commission into KPMG's practices mainly at SARS but also other entities that put the profession into disrepute.

- 3.To resolve the data integration challenges as a matter of urgency;
- 4. To finalise all the necessary funding decisions and outstanding payments, including those relating to student accommodation
- 5. To ensure the reconciliation of funding data between Universities and TVET colleges and NSFAS;






